Hereafter, Charles River Dog Training Club will be referred to as Club

Hereafter, Burri's Paws 4Dog Training LLC will be referred to as Secretary.

I attest that to the best of my knowledge, I do not have COVID-19 at the time of attending this event. I understand the risks of unknowing exposure to this and other illnesses by or to myself, my family, other participants, and other parties.

-I will practice social distancing of 6 feet or more.

-I will wear a mask in the building and on the grounds of Masterpeace, including in the ring.

-I have not been exposed to COVID-19 in the past three weeks.

-In the last 21 days I have not been tested and found to be positive, nor am I awaiting results.

-I do not have symptoms of COVID-19 now such as fever and sore throat, nor have I had symptoms in the past fourteen days.

-I have not traveled to a restricted state listed on the Commonwealth of MA website mass.gov/matraveler in the last 14 days.

-I will follow all AKC, Club, and Site rules and requirements to reduce any exposure and possibility of contracting or spreading the virus.

- I will also fully cooperate with and follow any State, County, and Local guidelines that have jurisdiction in the area in which the event is taking place.

-I agree that I am attending this event entirely at my own risk and I assume all risk as well as full responsibility for my own health, wellbeing, and safety during this event.

-I fully agree that the AKC, Club, Site, Secretary, owners, board members, employees, assistants and volunteers are in no way liable for any present or future COVID-19 exposure incurred at any time by any person, in attendance or not in attendance, during or after this event.

-I hereby waive and release AKC, Club, and Site, Secretary, the owners, board members, employees, assistants, and volunteers from any and all liability for damages or personal injury to me, my dogs, or my property.

-I understand that my signature on this form is required to complete my entry.

If any of the above should change prior to my arrival at the trial site or during the completion of the event that is the subject of this consent, I will inform the AKC, Club, Secretary, and Site and proceed accordingly in light of this new information.

I hereby indemnify and hold harmless AKC, Site, Secretary, and the Club, owners, board members, employees, assistants, and volunteers of any and all claims of liability to any third party arising out of my participation in this event. Any liability to anyone for any incident involving myself, the location, actions, or dogs of other participants will be my sole responsibility. I will assume any and all financial costs associated with my actions.
