**Judging starts: 11:00am.**

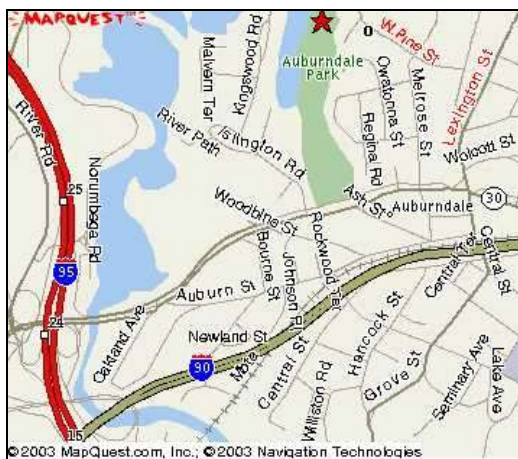
Held rain or shine. Shade, water & restrooms available. Bring chairs & lunch.
